



BIM POLICY

This document sets out the Building Information Modelling (BIM) Policy of Felix O'Hare & Company Limited. It covers activities taken by the company within the office and on-site. This policy will be renewed every 6 months for continued suitability within the construction industry and ensure that any changes in procedure are adopted by staff.

All UK government departments and agencies are required to phase in adoption of BIM on all projects by April 2016 (*Government Construction Strategy, May 2011*)

Our Commitment

We have already embarked on several builds using BIM principles, whilst also identifying suitable projects for BIM technologies which assist our customers to realise their own aspirations.
